Where Things Stand

Fiscal Year 2021 Appropriations

- House cleared 10 out of 12 bills before the August recess
- Senate stalled before Subcommittee markups
- Continuing Resolution until December 11, 2020

Water Resources Development Act of 2020

- H.R. 7575 passed the House by voice vote on July 29, 2020
- S. 3591 approved in Senate Committee on May 11, 2020
- Negotiations on a final package are ongoing

COVID-19 Relief

- Three major bills passed and signed into law before the end of March
- Additional relief stalled since April



FY21 House Appropriations Highlights

- Last year of the two-year bipartisan budget agreement
- House bills include separate COVID-19 stimulus titles
- House continues overall strong support for infrastructure:
 - \$7.63B USACE
 - \$1B BUILD
 - \$300M PIDP
 - \$500M CRISI
 - \$110M PSGP
 - \$90M DERA



FY21 House Appropriations Highlights USACE

- Record proposal for new starts: 7 studies and 7 construction
- 60-day work plan window
- No funds to reorganize USACE or transfer USACE outside of DoD
- \$5M to position water resources Projects to be managed as systems due to the implications of climate change
- Report on the structural conditions of federal breakwaters
- Report on recreation benefits that could be included in BCRs
- Encourages regional contracts for dredging



FY21 House Appropriations Highlights USACE

FY21 House USACE Funding Proposal:

- \$7.63B total
- •\$151M GI
- •\$2.6B CG
- •\$3.84B O&M
- •\$1.68B HMT

O&M work plan:

- \$38.455M Navigation Maintenance
- \$570M Deep-Draft Harbor & Channel
- \$50M Donor and Energy Transfer Ports
- \$55M Inland Waterways
- \$65M Small, Remote or Subsistence Navigation
- \$89.593M Other Authorized Project Purposes

WRDA 2020 Highlights

- HMT provisions inline with AAPA agreement (Sec. 101, 102 and 104 House)
- Sea level rise to be included in planning guidance (Sec. 112 House)
- Cooperation with federal and non-federal entities for enhanced inspection of aging water infrastructure (Sec. 1021 Senate)
- Creates path for contributed funds to dredge non-federal harbors and channels (Sec. 1045 Senate)
- Identification of \$10B in old, inactive projects for deauthorization (House)
- Expands Sec 1122 beneficial reuse of dredged material (Sec. 125 House: 30 projects and Sec. 1012: 40 projects)



WRDA 2020 Highlights

- Directs Corps Districts to develop a 5-year sediment management plan (Sec. 1019 Senate)
- Directs the ASA to produce a report on barriers to infrastructure and capital for ports and port authorities (Sec. 1058: Senate)
- Extends the Sec. 1043 pilot program until 2026 (Sec. 137 House and Sec. 1011 Senate)
- Authorizes new navigation feasibility studies (Sec. 201: 5 House and Sec. 1201: 4 Senate)
- Authorizes new navigation Chief's Reports (Sec. 401: 7 House and Sec.1401: 3 Senate)
